

## **IMPORTANT:** SENERGY<sup>™</sup> (selamectin) Parasiticide New Expiry with Extension to 24 Months.

Dear Doctor:

The purpose of this letter is to introduce new expiry dating for SENERGY<sup>™</sup> (selamectin) Parasiticide from 20 months to 24 months. Data submitted to the US Food and Drug Administration concludes that the product was found to be physically and chemically stable at 24 months. This change is effective immediately for SENERGY<sup>™</sup> (selamectin) Parasiticide.

This notification means that stability data for SENERGY<sup>™</sup> lots with imprints of 2021 expiry dates now support the use for 24 months from date of manufacture, as shown in the enclosed table. **Product that will be released in the future will have this extended dating already incorporated in the labeled date on the product package.** 

We kindly ask you to communicate this change to clients, with a reminder that the product should not be used past the extended expiry date. In addition, please write the extended expiration date on the adhered prescription instructions for the pet owner. For your convenience, a list of batch numbers with corresponding current and revised expiry dates is enclosed.
